

# RELOW ARE EXPERIENCES FROM COMMITTEE MEMBERS ON THE PROMISES OF EACH STEP

1. BUT, THERE EXISTS AMONG US A FELLOWSHIP, A FRIENDLINESS, AND AN UNDERSTANDING WHICH IS INDESCRIBABLY WONDERFUL. [16]
HENRY

MY WORK THROUGH STEP 1 HAS INVOLVED READING STEP ONE OUT OF THE 12 X 12 EVERY DAY FOR A FEW WEEKS, WRITING ABOUT CONSEQUENCES OF MY USING AND THINGS OVER WHICH I AM POWERLESS, READING PAGES 60—63 IN THE RIG ROOK EVERY MORNING, WORKING IN STEP WORKBOOKS, PRAYING IT SAYS IN THE CHAPTER THERE IS A SOLUTION OF THE RIG ROOK OF ALCOHOLICS ANONYMOUS, "THE FEELING OF HAVING SHARED IN A COMMON PERIL IS ONE ELEMENT IN THE POWERFUL CEMENT WHICH RINDS US. BUT THAT IN ITSELF WOULD NEVER HAVE HELD US TOGETHER AS WE ARE NOW JOINED. THE TREMENDOUS FACT FOR EVERY ONE OF US IS THAT WE HAVE DISCOVERED A COMMON SOLUTION."

HAVING WORKED STEP ONE SEEMINGLY COUNTLESS TIMES, I HAVE DESCRIBED IN DETAIL HOW MY LIFE HAS BECOME UNMANAGEABLE, HOW I HAVE DONE THINGS PREVIOUSLY THOUGHT BELOW ME, HOW I WAS UTTERLY BROKEN AND POWERLESS OVER ALCOHOL. GETTING VULNERABLE ABOUT THESE EXPERIENCES WITH OTHERS IN THE FELLOWSHIP HAS CREATED SOME IMMEDIATE AND LASTING BONDS; DEEP "ME TOO!" MOMENTS THAT CREATE BEAUTIFUL, EMPATHETIC FRIENDSHIPS. WE ALL HAVE A COMMON PERIL BY WHICH WE CARINGLY CONNECT; BUT, LIKE IT IS SAID IN THE BIG BOOK, OUR COMMON SOLUTION IS REALLY WHAT HOLDS US TOGETHER. THIS HAS BEEN MY EXPERIENCE.

AFTER ADMITTING MY POWERLESSNESS, AND ACCEPTING THAT I NEEDED HELP, I STARTED TO HEAR MORE ABOUT THE SOLUTION, ABOUT OTHERS' SUCCESSES IN THEIR NEW RECOVERY/SELFLESS/HP—CENTRIC LIVES. OUT OF WITNESSING THE SUCCESS OF OTHERS AND STORIES OF JOY AND COMPASSION, TALKING ABOUT HOW LONG IT'S TAKEN TO WRITE A 4TH STEP, BUT HOW LIGHT WE FEEL AFTER FINISHING STEP 7, MY FEELINGS OF WELLNESS AND BELONGING GREW EVEN FURTHER. THE CAMARADERIE FORMED AS A RESULT OF SHARING NEGATIVE EXPERIENCES EXPANDS FURTHER AS WE SHARE OUR VICTORIES AND SEE THAT OUR LIVES CAN CHANGE. A FEELING OF HOPE EMERGES AFTER STICKING AROUND AND DOING THE WORK, AND THIS HOPE CAN CREATE A POSITIVE FEEDBACK LOOP IN OUR FELLOWSHIP PRODUCING WONDERFUL EXPERIENCES.

I ONCE HELPED A GROUP OF YOUNGER ADDICTS COMPLETELY NEW TO RECOVERY GET INTO THE PROGRAM. THEY WERE EXCITED ABOUT IT, MOTIVATED, AND CURIOUS—ALBEIT BEATEN FROM THEIR RECENT DRINKING AND DRUGGING ESCAPADES. THEY WENT THROUGH ALL THE HIGH AND LOW EMOTIONS BUT KEPT READING THE LITERATURE, BEING PRESENT FOR EACH OTHER, PRACTICING SPIRITUAL PRINCIPLES, ASKING QUESTIONS. I WAS SO PROUD OF THEM AND MYSELF; FEELINGS FOREIGN TO ME FROM YEARS OF LIVING IN MY DISEASE. ONE DAY THEY WERE STARTING A MEETING TOGETHER AND STUMBLING TO GET THE PROCESS DOWN; I REMEMBER SMILING WATCHING THEM AND BEING OVERWHELMED WITH A FEELING I DESCRIBE AS A GLIMPSE OF JOY. I NEVER HAD A LIFE—CHANGING SPIRITUAL EXPERIENCE LIKE BILL WILSON, BUT THAT WAS MY LITTLE SPIRITUAL EXPERIENCE—AN INDESCRIBABLY WONDERFUL FEELING OF FELLOWSHIP, FRIENDLINESS, AND UNDERSTANDING THAT EXISTS AMONG US ROOTED FROM OUR SELF—FAILINGS AND GROWING FROM THE JOY WE GET AS A RESULT OF WORKING THE STEPS.

2. WE HAVE FOUND MUCH OF HEAVEN AND WE HAVE BEEN ROCKETED INTO A FOURTH DIMENSION OF EXISTENCE OF WHICH WE HAD NOT EVEN DREAMED.

#### REBECCA

WHEN I FIRST CAME INTO THE PROGRAM OF ALCOHOLICS ANONYMOUS, I FELT UTTERLY ALONE AND AS IF THERE WAS SURELY NOT ANOTHER PERSON WHO COULD POSSIBLY UNDERSTAND HOW I FELT OR WHAT I WAS GOING THROUGH. IF YOU LAUGHED, THEN YOU REMEMBER WHAT IT WAS LIKE!

OF COURSE, IN THE BEGINNING I HEARD A LOT ABOUT "IF YOU WANT WHAT WE HAVE, THEN DO WHAT WE DO", BUT I WAS LEFT THINKING, "WELL.WHAT EXACTLY DO YOU HAVE?". I CONTINUED GOING TO MEETINGS THROUGHOUT THE YEARS LEARNING LITTLE BY LITTLE WHAT THEY HAD RECEIVED DUE TO WORKING THE PROGRAM. YET, IT WASN'T UNTIL I FINALLY GOT A SPONSOR AND STARTED WORKING THE STEPS THAT I TRULY BEGAN TO UNDERSTAND WHAT THEY HAD FOUND... HEAVEN.

HEAVEN APPEARED TO ME IN MANY DIFFERENT FORMS: THE SUDDEN GROWTH IN OBSERVATION OF MY BEAUTIFUL SURROUNDINGS, THE LOVE AND SUPPORT GIVEN BETWEEN THE MEMBERS, AND THE STRENGTH, HOPE, AND EXPERIENCES THAT I WAS SELFLESSLY GIFTED. THESE MINUTE DETAILS OF HEAVEN WERE JUST THE BEGINNING.

AS I CONTINUED ON MY SORER JOURNEY, I ENDED UP FINDING A VOID WHERE MY CONNECTION TO MY HIGHER POWER HAD SPORADICALLY BEEN THROUGHOUT MY LIFE I WAS SURPRISED TO LEARN I WASN'T AS CONNECTED AS I HAD PREVIOUSLY THOUGHT WHEN I WAS DRINKING. ACCEPTING THE POWERLESSNESS OVER ALCOHOL TURNED INTO RECOGNIZING THE SELFISHNESS IN MY ACTIONS AND REACTIONS, WORDS, PERCEPTIONS, AND MY SPIRITUALITY. SLOWLY, BUT SURELY, MY FAITH WAS REGAINED, I CAME TO BELIEVE THAT A POWER GREATER THAN MYSELF COULD RESTORE ME TO SANITY, AND I FELT UNDOUBTEDLY RECONNECTED WITH THIS POWER ONCE AGAIN. THIS TIME, HOWEVER, ON A TWO—WAY STREET: I WAS ABLE TO AUTHENTICALLY SHOW UP FOR OTHERS IN WAYS I HADN'T BEEN ABLE TO BEFORE, SHARE MY STRENGTHS, HOPE, AND EXPERIENCES WITH OTHER SUFFERING ALCOHOLICS, AND HAVE FAITH THAT THE POWER'S WILL WOULD BE DONE AND NOT MY OWN. I FOUND FREEDOM IN KNOWING THAT EVERYTHING WAS GOING TO BE ALRIGHT AND I FOUND A DEEPER PART OF HEAVEN THAT EXISTS BETWEEN SOULS.

AS TIME PASSED AND I CONTINUED ON, SOBER, I HAVE COME INTO CONTACT WITH SOME TRULY REMARKABLE HIGHER POWER TIMINGS, CONNECTIONS, AND OPPORTUNITIES THAT CONTINUE TO BAFFLE ME. I SEE ITS HAND IN MY EVERY DAY, BOTH MINOR AND MAJOR, WITHIN ME, HOW I INTERACT WITH THE WORLD, AND HOW THE WORLD INTERACTS WITH ME. IT IS A TRULY REMARKABLE SPACE TO BE IN, AND TO THINK, I AM JUST UNDER FOUR YEARS IN.

NOW, I AM GRATEFUL TO SAY AS I SIT HERE WRITING THIS, THAT I HAVE UNDOUBTEDLY COME TO KNOW THAT I HAVE FOUND MUCH OF HEAVEN HERE ON EARTH AND HAVE BEEN ROCKETED INTO THE ASTONISHING FOURTH DIMENSION, WHERE I THINK I'LL STAY FOR A WHILE.

3. AS WE FELT NEW POWER FLOW IN, AS WE ENJOYED PEACE OF MIND, AS WE DISCOVERED WE COULD FACE LIFE SUCCESSFULLY, AS WE RECAME CONSCIOUS OF HIS PRESENCE, WE REGAN TO LOSE OUR FEAR OF TODAY, TOMORROW OR THE HEREAFTER. WE WERE REBORN.

I USED TO BELIEVE BEING A REAL ADULT MEANT HAVING THE PERFECT PLAN AND EXECUTION FOR EVERY SITUATION. THERE IS A HUGE RELIEF AND PEACE IN ALLOWING GOD TO BE IN CHARGE. I NO LONGER HAVE TO KNOW AND CONTROL EVERY ASPECT OF MY LIFE. I CAN DO HIS WORK WITHOUT GOING CRAZY OVER THE INSIGNIFICANT DETAILS. TODAY, I CAN HONESTLY SAY "THY WILL BE DONE" ONE DAY AT A TIME.

4. IF WE HAVE BEEN THOROUGH ABOUT OUR PERSONAL INVENTORY, WE HAVE WRITTEN DOWN A LOT. WE HAVE LISTED AND ANALYZED OUR RESENTMENTS. WE HAVE BEGUN TO COMPREHEND THEIR FUTILITY AND THEIR FATALITY. WE HAVE COMMENCED TO SEE THEIR TERRIBLE DESTRUCTIVENESS. WE HAVE BEGUN TO LEARN TOLERANCE, PATIENCE AND GOOD WILL TOWARD ALL MEN, EVEN OUR ENEMIES, FOR WE LOOK ON THEM AS SICK PEOPLE. WE HAVE LISTED THE PEOPLE WE HAVE HURT BY OUR CONDUCT, AND ARE WILLING TO STRAIGHTEN OUT THE PAST IF WE CAN. [P. 70]

#### EMILY

WHEN I WORKED STEP 4 THE FIRST TIME, I HAD A HARD TIME SEEING WHAT MY RESENTMENTS AND FEAR HAD TO DO WITH MY SOBRIETY. EVEN AFTER WORKING IT THE FIRST TIME I DIDN'T QUITE UNDERSTAND THE RELIEF THAT WAS PROMISED TO ME. MY FIRST YEAR OF SOBRIETY WAS EXTREMELY TURBULENT, AND WHILE WORKING THE STEPS DID GIVE ME RELIEF, THERE WAS A LOT OF OTHER THINGS HAPPENING THAT MADE LIVING HAPPY, JOYOUS, AND FREE A DIFFICULT FEAT. AS I CONTINUED IN MY SOBRIETY, I STARTED WORKING THE STEPS FOR A SECOND TIME. THIS TIME AROUND WAS VASTLY DIFFERENT, I HAD A BETTER UNDERSTANDING OF WHAT IT TAKES TO STAY SOBER, AND WAS INTIMATELY AWARE OF HOW MY RESENTMENTS CAN LEAD ME TO TAKING A DRINK. IT CAME TO A HEAD SHORTLY AFTER I GOT OFF PROBATION WHEN, FOR THE FIRST TIME IN A COUPLE YEARS, I WAS HAVING ACTUAL ALCOHOL CRAVINGS. ABOUT A WEEK BEFORE THIS, MY SPONSOR HAD TOLD ME TO START WORKING ON MY FOURTH STEP, WHICH I HAD BEEN PROCRASTINATING I CALLED A FRIEND WHO TOLD ME WHAT I NEEDED TO HEAR AT THAT MOMENT: ESSENTIALLY THAT IF I DON'T WORK THE STEPS I WILL DRINK BECAUSE I AM AN ALCOHOLIC AND THAT IS MY NATURAL INCLINATION. AFTER THAT CONVERSATION, I IMMEDIATELY STARTED WORKING ON MY FOURTH STEP WRITING DOWN MY RESENTMENTS. THERE IS SOMETHING TO BE SAID FOR WRITING THINGS DOWN. THE IMMEDIATE CATHARSIS OF GETTING THINGS OUT OF MY HEAD AND ON PAPER WAS PROFOUND. I WAS ABLE TO START SEEING WHERE I HAD LET OTHER PEOPLE'S BEHAVIOR WOUND ME, AND HOW HOLDING ONTO THESE PAINS AND TRAUMAS, I WAS CONTINUING TO HURT MYSELF. I WAS ABLE TO BEGIN SEEING HOW NO MATTER WHAT OTHERS HAVE DONE TO ME OR THEIR PERCEIVED OFFENSES, THEY ARE ALL ESSENTIALLY SICK PEOPLE AND IF I CONTINUE TO BLAME THEM FOR MY OWN WOUNDS, I CAN NEVER HEAL FROM THEM.

5. WE CAN LOOK THE WORLD IN THE EYE. WE CAN BE ALONE AT PERFECT PEACE AND EASE. OUR FEARS FALL FROM US. WE BEGIN TO FEEL THE NEARNESS OF OUR CREATOR. WE MAY HAVE HAD CERTAIN SPIRITUAL BELIEFS, BUT NOW WE BEGIN TO HAVE A SPIRITUAL EXPERIENCE.

#### BEKA

BEFORE WORKING THE STEPS I WAS CRIPPLED WITH ANXIETY AND SELF DOUBT. AT THE TIME I DIDN'T KNOW THE STEP PROMISES. BUT ONE OF THE PROMISES FROM STEP 5 IS "WE CAN BE ALONE AT PERFECT PEACE AND EASE. OUR FEARS FALL FROM US." THESE PROMISES SHOW UP IN MY LIFE EVERY SINGLE DAY. BECAUSE REFORE I WORKED THE STEPS [PARTICULARLY STEP 5] I WAS CRIPPLED IN MY ANXIETY AND SELF DOUBT. BUT WHEN I WORKED IT WITH MY SPONSOR I FELT SO MUCH OF THAT SLIP AWAY AND I NO LONGER LIVE IN THAT DARKNESS. ALL OF THIS TO SAY THAT THE PROMISES DO COME TRUE. IF YOU WORK THE PROGRAM AND YOU DO THE NEXT RIGHT THING.

6. OF COURSE, THE OFTEN DISPUTED QUESTION OF WHETHER GOD CAN—AND WILL, UNDER CERTAIN CONDITIONS—REMOVE DEFECTS OF CHARACTER WILL BE ANSWERED WITH A PROMPT AFFIRMATIVE BY ALMOST ANY A.A. MEMBER. TO HIM, THIS PROPOSITION WILL BE NO THEORY AT ALL; IT WILL BE JUST ABOUT THE LARGEST FACT IN HIS LIFE. [12 AND 12, P 63]

#### AIDEN

THROUGH TAKING THE STEPS, LISTENING TO THE SUGGESTIONS OF MY SPONSOR, AND PRACTISING THE STEPS IN MY EVERYDAY LIFE, MY EXPERIENCE IS THAT GOD CAN AND WILL REMOVE MY DEFECTS OF CHARACTER. FROM WHAT I'VE EXPERIENCED IT IS ENTIRELY CONTINGENT ON HOW THOROUGHLY I WORK MY PROGRAM TODAY. GOD DOES FOR ME WHAT I CANNOT DO FOR MYSELF IF I LET HIM. WHEN I TAKE MY LIFE INTO MY OWN HANDS, IT PREVENTS HIM FROM REMOVING MY DEFECTS.

#### 7. "NEVER WAS THERE ENOUGH OF WHAT WE THOUGHT WE WANTED.

IN ALL THESE STRIVINGS, SO MANY OF THEM WELL INTENTIONED, OUR CRIPPING HANDICAP HAD BEEN OUR LACK OF HUMILITY. WE HAD LACKED THE PERSPECTIVE TO SEE THAT CHARACTER—BUILDING AND SPIRITUAL VALUES HAD TO COME FIRST, AND THAT MATERIAL SATISFACTIONS WERE NOT THE PURPOSE OF LIVING." [12 & 12, P. 71]

#### 4EOR41E

THIS PROGRAM HAS NOT TAUGHT ME HOW TO DRINK LIKE A LADY AND MANAGE MY LIFE. THIS PROGRAM HAS TAUGHT ME HOW TO LIVE LIFE, WITHOUT USING ALCOHOL TO HELP ME FEEL OR NUMB MY EMOTIONS. THE STEPS HAVE TAUGHT ME HOW TO MANAGE LIFE ON LIFE'S TERMS WITHOUT PUTTING SUBSTANCES INTO MY BODY FOR FALSE SUPPORT OR FALSE SATISFACTION.

IT'S WHEN I GET OUT OF MYSELF AND RECOME WILLING TO SERVE THAT I FIND PRESENCE, PERSPECTIVE, GOD AND PEACE IT IS BECAUSE OF THE MEN AND WOMEN WHO CAME REFORE ME WHO PRACTISED THESE PRINCIPLES IN ALL OF THEIR AFFAIRS OF LIFE THAT I CAN HAVE A NEW LIFE, TOO. OFTEN I HEAR, "I'M NOT MUCH, RUT I'M ALL I THINK ABOUT". THIS YEAR I WILL BE PRACTICING SEEKING PERSPECTIVES THAT ARE NOT MY OWN. TO CULTIVATE MORE FORGIVENESS AND COMPASSION FOR MYSELF AND OTHERS.

AFTER STEPS 4 AND 5 WE STILL HAVE CHARACTER DEFECTS TO LIVE WITH. STEPS 6 AND 7 ALLOWS US TO SURRENDER TO THE SPIRIT OF THE UNIVERSE AND THE GRACE HE LOVINGLY GIFTS US. THESE ARE THE BEAUTIFUL GIFTS, THE SPIRITUAL VALUES, THAT WE RECEIVE WHEN WE GET TO MEETINGS AND CONFERENCES AND WORK WITH OUR SPONSORS AND SPONSEES. IT SEEMS LIKE WE BEGIN TO HEAL AND HAVE A NEW FOUND HOPE OF SOULFUL CONNECTIONS.

READING STEPS 6 & 7 IN THE 12&12 AND DROP THE ROCK WITH MY SPONSOR WAS A SPIRITUAL EXPERIENCE. IT WAS A SLOW, PATIENT PROCESS. SOMETIMES PRODUCING FRUITS OF PAIN AND OTHER TIMES THE PEACE OF GOD'S PRESENCE. IT IS A CONTINUOUS JOURNEY OF LETTING GO, OPENING YOUR MIND AND SINKING INTO YOUR HEART, AND ALLOWING GOD TO DO FOR US WHAT WE CANNOT DO FOR OURSELVES.

SLOW DOWN AND SURRENDER. EASY DOES IT.

"WE NEVER THOUGHT OF MAKING HONESTY, TOLERANCE, AND TRUE LOVE OF MAN AND GOD THE DAILY BASIS OF LIVING". [12 & 12 P. 72]

#### 8. IT IS THE BEGINNING OF THE END OF ISOLATION FROM OUR FELLOWS AND FROM GOD [12 AND 12, P. 82]

"AN ALCOHOLIC IN HIS CUPS IS AN UNLOVELY CREATURE," AND THAT APPLIES TOO WHEN THE ALCOHOLIC IS IN ISOLATION FROM THEIR FELLOWS AND FROM GOD; A PLACE I FOUND MYSELF AT, AT 4 YEARS SOBER. WHILE OTHERS WERE ADJUSTING BACK TO NORMALCY POST— PANDEMIC, I WAS MOVING 45 MINUTES AWAY FROM MY HOME GROUP AND WITHOUT A SPONSOR BECAUSE MINE HAD JUST MOVED BACK TO HER HOME COUNTRY OF AUSTRALIA. LIKE MOST OTHER ALCOHOLICS, I AM A SERIAL ISOLATOR IN THE PITS OF MY ALCOHOLISM, I WAS ENSLAVED TO THE BONDAGE OF SELF. A PRISONER TO MY FEARS, THOUGHTS, AND APARTMENT, I HAD A PSYCHIATRIST ONCE EXPLAIN IT LIKE THIS SOCIAL ANXIETY IS LIKE BEING IN AN ABUSIVE RELATIONSHIP WITH YOURSELF. THE MORE YOU GIVE IN TO THE DEMANDS TO STAY ALONE WHERE IT SEEMS MORE COMFORTABLE, THE LOUDER THAT ABUSIVE VOICE GETS, AND THE HARDER IT GETS TO EVER LEAVE. MY ALCOHOLISM EXACERBATED THAT AND THE PANDEMIC DID SO AS WELL I REVELLED IN THE CHANCE TO WORK AND ATTEND MEETINGS FULLY REMOTE. I DID NOT HAVE TO OVERCOME MY ANXIOUS THOUGHTS OF BEING SOCIAL AND SO AGAIN, I BECAME A PRISONER — NOT ONLY SOCIALLY BUT SPIRITUALLY AS WELL I LET MY RESENTMENTS TOWARDS RELIGION DUE TO THE POLITICAL CLIMATE DURING THE PANDEMIC SUFFOCATE MY RELATIONSHIP WITH MY HIGHER POWER I WAS WITHOUT A SOLUTION AND THANK GOD I DIDN'T DRINK SERVICE WORK, EXCEPTIONALLY IN REGARDS TO TXSCYPAA, WAS A SAVING GRACE FOR ME. I WAS A MEMBER OF THE TXSCYPAA 40 HOST COMMITTEE AND SO AT LEAST I HAD SOMETHING TETHERING ME TO AA AND MY SORRIETY AS I HAD NOT BEEN ABLE TO OVERCOME MY FEARS AROUND GOING TO MEETINGS IN MY NEW AREA TO SET DOWN SOME ROOTS AND FIND A NEW SPONSOR. I FELT LIKE A FRAUD AND WAS ASHAMED TO HAVE YEARS OF SOBRIETY AND NO SPIRITUALITY TO SHOW FOR IT. BUT AS THE CONFERENCE APPROACHED, I BEGAN MEETING WITH THE COMMITTEE IN PERSON. EVER SO SLIGHTLY, MY FELLOWSHIP BEGAN TO GROW AGAIN. I STOOD FOR ADVISORY AND FOR THE FINAL ALTERNATE SPOT, I WAS NOT ELECTED AFTER THE VOTE WENT TO THE HAT. TRUTHFULLY, I WAS PRETTY SAD BUT IT WOUND UP BEING THE ABSOLUTE BEST THING FOR ME — MY HIGHER POWER WAS DOING FOR ME WHAT I COULD NOT DO FOR MYSELF. I LEFT THE CONFERENCE AND IMMEDIATELY TEXTED TWO OTHER MEMBERS OF THE JUST CONCLUDED HOST COMMITTEE AND ASKED IF WE WERE GOING TO START A BID AGAIN IN OUR AREA — AND THANK GOD THEY SAID YES. THESE PAST TWO YEARS BIDDING GOD HAS WORKED TREMENDOUSLY IN MY LIFE. I AM NO LONGER ISOLATED, I HAVE A FELLOWSHIP THAT I AM TREMENDOUSLY GRATEFUL FOR THAT I TRULY DO NOT THINK I WOULD HAVE HAD I BEEN ELECTED TO ADVISORY. THIS FELLOWSHIP HAS HELPED ENABLE ME TO FIND A NEW SPONSOR THROUGH SUGGESTING NEW MEETINGS FOR ME AND GETTING ME CONNECTED TO WOMEN IN MY AREA, WHICH THEN PROMPTED ME TO WORK THE STEPS AGAIN. MY RELATIONSHIP WITH MY HIGHER POWER HAS EBBED AND FLOWED, AND MORE TIMES THAN NOT, IT IS MY FELLOWS AND THEIR HONESTY IN THEIR STRUGGLES THAT HAVE BROUGHT ME BACK TO GOD. A VISION FOR YOU SAYS IT BEST, "YOU MUST REMEMBER THAT YOUR REAL RELIANCE IS ALWAYS UPON HIM. HE WILL SHOW YOU HOW TO CREATE THE FELLOWSHIP YOU CRAVE." I LOVE THIS SPECIAL GROUP OF ALCOHOLICS THAT BRING ME UNENDING AMOUNTS OF JOY AND MORE THAN LIKELY SAVED MY LIFE.

9. WE ARE GOING TO KNOW A NEW FREEDOM AND A NEW HAPPINESS. WE WILL NOT REGRET THE PAST NOR WISH TO SHUT THE DOOR ON IT. WE WILL COMPREHEND THE WORD SERENITY. WE WILL KNOW PEACE. NO MATTER HOW FAR DOWN THE SCALE WE HAVE GONE, WE WILL SEE HOW OUR EXPERIENCE CAN RENEFIT OTHERS. THAT FEELING OF USELESSNESS AND SELF—PITY WILL DISAPPEAR. WE WILL LOSE INTEREST IN SELFISH THINGS AND GAIN INTEREST IN OUR FELLOWS. SELF—SEEKING WILL SLIP AWAY. OUR WHOLE ATTITUDE AND OUTLOOK ON LIFE WILL CHANGE. FEAR OF PEOPLE AND ECONOMIC INSECURITY WILL LEAVE US. WE WILL INTUITIVELY KNOW HOW TO HANDLE SITUATIONS WHICH USED TO BAFFLE US. WE WILL SUDDENLY REALIZE THAT GOD IS DOING FOR US WHAT WE COULD NOT DO FOR OURSELVES.

#### AVA P

THE NINTH STEP PROMISES WAS WHERE I FOUND THAT GOD HAD ALWAYS HAD A PURPOSE FOR ME. SHORTLY AFTER MY NINTH STEP I SAT WITH A NEWCOMER AND TOLD HER OF SOME OF MY MOST SHAMEFUL AND DEMORALISING EXPERIENCES, AS I SAW HER SHOULDERS FALL WHILE SHE LET OUT A SIGH OF RELIEF, I COULD SEE SHE WAS NO LONGER ALONE AND NEITHER WAS I. IN THAT MOMENT I SAW THAT THE WORST OF MY LIFE NOW HAD A PURPOSE, YEARS OF SELF PITY DISSOLVED IN A STARBUCKS PARKING LOT. I COULD HAVE PEACE IN KNOWING THAT MY LIFE WAS NO LONGER ABOUT ME, BUT ABOUT USING MY EXPERIENCE TO HELP OTHERS. SUDDENLY MY LIFE HAD ALWAYS REEN ABOUT HELPING GOD'S CHILDREN AND I WAS SIMPLY AN EMPLOYEE. I FOUND A NEW FREEDOM AND A NEW HAPPINESS IN HELPING OTHERS. GOD HAD DONE FOR ME WHAT I COULD HAVE NEVER DONE FOR MYSELF.

10. BY THIS TIME SANITY WILL HAVE RETURNED. WE WILL SELDOM BE INTERESTED IN LIQUOR. IF TEMPTED, WE RECOIL FROM IT AS FROM A HOT FLAME. WE REACT SANELY AND NORMALLY, AND WE WILL FIND THAT THIS HAS HAPPENED AUTOMATICALLY. WE WILL SEE THAT OUR NEW ATTITUDE TOWARD LIQUOR HAS BEEN GIVEN US WITHOUT ANY THOUGHT OR EFFORT ON OUR PART. IT JUST COMES! THAT IS THE MIRACLE OF IT. WE ARE NOT FIGHTING IT, NEITHER ARE WE AVOIDING TEMPTATION. WE FEEL AS THOUGH WE HAD BEEN PLACED IN A POSITION OF NEUTRALITY—SAFE AND PROTECTED. WE HAVE NOT EVEN SWORN OFF. INSTEAD, THE PROBLEM HAS BEEN REMOVED. IT DOES NOT EXIST FOR US. WE ARE NEITHER COCKY NOR ARE WE AFRAID. [PP. 84—85]

THE FIRST TIME I REALLY FELT THAT I HAD RECOVERED FROM A HOPELESS STATE OF MIND AND BODY WAS WHEN I BEGAN EXPERIENCING THE 10TH STEP PROMISES. ALTHOUGH I REALLY VALUE THEM NOW, I NEVER CAME INTO AA TO GROW A RELATIONSHIP WITH GOD OR BECOME A BETTER PERSON. I

SIMPLY WANTED TO QUIT DRINKING. THE CONSTANT ROMANTICISING HOW I MIGHT BE ABLE TO DRINK AGAIN FOLLOWED ME FOR MOTHS AND DID NOT SUBSIDE UNTIL I GOT INTO THE LATER STEPS, I CAN'T TELL YOU WHEN I WAS PLACED INTO A POSITION OF NEUTRALITY AROUND ALCOHOL BUT I CAN REMEMBER SPECIFICALLY A MOMENT WHERE I WAS SITTING QUIETLY ON A SATURDAY TRYING TO THINK OF WHAT I MIGHT ENJOY DOING, AND I RELIED I HAD NOT THOUGHT ABOUT WANTING TO DRINK IN QUITE AWHILE. IT WAS THE LONGEST PERIOD I HAD EXPERIENCED SINCE I WAS IN HIGH SCHOOL. I LATER TALKED TO MY SPONSOR ABOUT IT AND HE TOOK ME TO PAGE 84 IN THE BOOK AND READ THE NEXT FEW PAGES. THE BOOK REALLY SPOKE TO ME IN THAT MOMENT, FOR I HADN'T REALISED TO QUITE THE EXTENT THE PROGRAM HAD BEEN WORKING ON ME, I NOTICED THAT ALONG WITH ALCOHOL NO LONGER TORMENTING MY THOUGHTS I ALSO CEASED FIGHTING MANY OTHER SITUATIONS AND PEOPLE THAT I WOULD HAVE ISSUES WITH IN MY DAILY LIFE. IT WAS THEN THAT I REALISED THAT THROUGH CONSTANT INVENTORY AND ASKING MYSELF MANY TIMES EACH DAY WHAT GOD WOULD HAVE ME BE, I WAS FINALLY ABLE TO BEGIN FINDING TRUE PEACE AND SERENTY IN SOBRIETY.

11. MUCH HAS ALREADY BEEN SAID ABOUT RECEIVING STRENGTH, INSPIRATION, AND DIRECTION FROM HIM WHO HAS ALL KNOWLEDGE AND POWER. IF WE HAVE CAREFULLY FOLLOWED DIRECTIONS, WE HAVE BEGUN TO SENSE THE FLOW OF HIS SPIRIT INTO US. TO SOME EXTENT WE HAVE BECOME GOD—CONSCIOUS.

WE HAVE BEGUN TO DEVELOP THIS VITAL SIXTH SENSE. [P.85]

#### KATIE C.

WHEN I THINK OF WHAT BEING GOD—CONSCIOUS LOOKS LIKE IN MY LIFE I THINK OF A SOFT BLANKET. THIS IDEA STEMMED FROM MY CHILDHOOD, REALLY.

I REMEMBER THIS ONE MEMORY AFTER MY PARENTS DIVORCED, THINKING "EVERYTHING WILL BE OKAY". THE FEELING ITSELF FELT LIKE A SOFT BLANKET DRAPED AROUND ME. IT WASN'T UNTIL I WAS A FEW MONTHS SOBER THAT I WAS ABLE TO HAVE THIS FEELING AGAIN. THIS WAS WHEN I RECOGNIZED THIS AS MY GOD CONSCIOUSNESS. I FEEL GOD'S SPIRIT THE MOST WHEN I HAVE BEEN ABLE TO REMAIN PRESENT AND GRATEFUL. IF I AM CONSTANTLY PRAYING, FOLLOWING DIRECTIONS, LISTENING AND TALKING TO MY SPONSOR AND OTHER ALCOHOLICS, I GET TO REMAIN PRESENT AND GRATEFUL. THAT IS MY EXPERIENCE WITH THE SIXTH SENSE OF GOD—CONSCIOUSNESS.

12. WHEN WE LOOK BACK, WE REALISED THAT THE THINGS WHICH CAME TO US WHEN WE PUT OURSELVES IN GOD'S HANDS WERE BETTER THAN ANYTHING WE COULD HAVE PLANNED. (P. 100)

NATE E

THERE IS NO WAY FOR ME TO COUNT OR RECALL ALL OF THE TIMES MY PLANS HAVE FAILED IN SOBRIETY. MY FAITH HAS NOT BEEN PERMANENT THROUGH THESE LETDOWNS. I HAVE KICKED AND SCREAMED AND CURSED GOD AT TIMES OVER THESE LAST EIGHT YEARS. SICKNESS, DEATH, LOST FRIENDSHIPS, CALCULUS, WORK TROUBLES AND MORE HAVE MADE ME WANT TO PLAN AND CONTROL THE WORLD AROUND ME. FORTUNATELY, I ALWAYS GET TIRED OF TRYING TO FORCE MY WAY. SOMETIMES THAT TAKES LONGER THAN I WOULD LIKE TO ADMIT. THE SURRENDER I MADE WHEN TAKING MY FIRST STEP COMES BACK AND I REMEMBER THAT GOD IS MUCH MORE QUALIFIED THAN I AM AT DIRECTING MY LIFE. NOW I GET TO LOOK BACK AT ALL THE TWISTS AND TURNS OF MY JOURNEY. IF ANY ONE OF MY THOUSANDS OF PLANS HAD COME TO FRUITION I WOULD NOT BE WHERE I AM TODAY. THE SLOW, STEADY PROGRESS THAT THE 12 STEPS BRING IS MY REWARD FOR CARRYING THE MESSAGE TO THE STILL SUFFERING ALCOHOLIC. 





<u>CANCELLATION/ATTRITION</u>: Client and Hotel have entered into a binding commitment. The Hotel is committed to providing the rooms and services specified in this Agreement and the Hotel has offered special rates and other concessions based upon anticipated revenues for Client's event(s). The anticipated revenue includes the revenue from the food and beverage services Client may have requested and any ancillary services, such as special labor fees, equipment rentals and other charges.

If Hotel cancels this Agreement or is unable to provide the requested event space, the Hotel will work with Client to arrange alternative space at the prices set forth herein. Hotel will arrange for comparable space in the same vicinity of the Hotel and shall provide, without charge, necessary transportation between the alternative site and the Hotel. Hotel's liability is limited to these remedies and Hotel shall not be liable for any consequential, punitive or special damages.

If Client decides to cancel this Agreement, reduce the size of the event(s) and/or reduce the agreed number of attendances, or reduce the amount of food and beverage services, Client agrees that the Hotel will suffer damages. Such damages will be a result of Hotel's inability to offer Client's unused space or services to another party and /or the cost to the hotel of trying to re-sell space/services. The exact amount of damages will be difficult to determine. Therefore, Client agrees that the following liquidated damage clauses are a reasonable effort by the parties to agree in advance on the amount of damages. It is agreed that these amounts will be due regardless of the Hotel's ultimate ability to re-sell some or all of the space or services.

ATTRITION CLAUSE: The parties agree that the Client and the Hotel will share in the loss of revenues suffered by the Hotel in the event of the Client's failure to utilize all of the sleeping rooms, event space, and services agreed to herein. The Client therefore agrees to pay a percentage of lost revenue.

For food and beverage revenue, lost revenue will be calculated by subtracting the exact amount of food and beverage consumed
from the agreed upon F&B Minimum Revenue Guarantee. The lost revenues for Room Rental and/or other services will be a
function of agreed upon rates and/or charges as outlined in this document.





Hotel is relying upon Client's use of the Room Night Commitment. Client agrees that a loss will be incurred by Hotel if Client's actual usage is less than 80 of the Room Night Commitment. If Client's actual usage is less than 80% of the Room Night Commitment, Client agrees to pay, as liquidated damages and not as a penalty, the difference between 80% of the Room Night Commitment and Client's actual usage, multiplied by the average group room rate, plus applicable taxes. In the event of reductions in the Room Night Commitment of more than 80%, the Hotel may adjust any concessions previously offered in this Agreement, including those concessions offered on a complimentary basis, and may also adjust the Function Space in direct proportion to the reduction in the Room Night Commitment.

<u>CANCELLATION SLIDING SCALE:</u> Client agrees that if it cancels this Agreement for any reason, the Hotel will suffer damages. The closer in time the cancellation occurs, the greater the damages will be. Therefore, Client agrees to pay Hotel at the time of cancellation a liquidated damages fee, as follows:

More than 365 days prior to arrival date: forfeiture of any/all event deposits

More than 180 days, less than 365 days prior to arrival date:

More than 90 days, less than 180 days prior to arrival date:

More than 30 days, less than 90 days prior to arrival date:

For food and beverage revenue, lost revenue will be the agreed upon F&B "Guaranteed Amount" in Section 3.5. The lost revenues for Room Rental and/or other services will be a function of agreed upon rates and/or charges as outlined in this document.

<u>SIGNS AND DISPLAYS/USE OF HOTEL NAME:</u> Client shall not display signs in Hotel nor use the name/logo of the Hotel in any promotional brochures or ads without prior approval of the General Manager of Hotel. It is further agreed that no sign, banner or display shall be affixed to any part of Hotel. Any damages caused to the walls, fixtures or carpet will be billed to Client.

<u>SECURITY:</u> Hotel may, in its sole discretion, require Client to take certain security measures in order to maintain security in light of the size or nature of the function. Such security measures may include the requirement to hire sufficient security personnel from a reputable agency that is approved by the Hotel prior to the function.

<u>SHIPPING AND PACKAGES:</u> In the event Client will be shipping packages to Hotel, Client must notify Hotel at least one week in advance. All packages sent to Hotel should include the name of Client Event, date of program and number of items. Shipment should arrive no earlier than three (3) days prior to event. Hotel accepts no responsibility or liability for the delivery, security or condition of the packages.

PARKING: Current self-parking for overnight guests is complimentary.

HOTEL CONTACT/NOTICES: All notices, offers, acceptances, requests and other communications hereunder shall be in writing and shall be deemed to delivered if hand delivered or sent by overnight Express, or certified or registered mail to the Client contact on the first page of this Agreement, or, if to Hotel, to the following address: 2540 Meacham Blvd, Fort Worth, TX 76106 Attn: Director of Catering and Convention Services. Hotel may change Hotel's designated contact at any time upon notice. Hotel will not be bound by any notice unless delivered to Hotel in the manner specified herein.

<u>SIGNING AUTHORITY:</u>The following individuals have the authority to sign for the Master Account and/or act on behalf of and bind the Client pursuant to the terms of this Agreement:

<u>DAMAGE CLAUSE</u>: In the unlikely event that damage to any Hotel property occurs as a result of any guest related to Client, Client agrees to assume all liability and expense and agrees that, in addition to any other rights as against such guest or others, Hotel may charge Client's Master Account or directly bill Client for all such charges. Client shall indemnify, defend and hold harmless Hotel and its officers, directors, partners, affiliates, members and employees from and against all demands, claims, damages to persons and/or property, losses and liabilities, including reasonable attorney fees (collectively "Claims") arising out of or caused by Client's negligence or intentional misconduct. Client shall not have waived or be deemed to have waived, by reason of this paragraph, any defense that it may have with respect to such claims.





<u>CLIENT'S PROPERTY:</u> Client agrees and acknowledges that Hotel will not be responsible for the safe-keeping of equipment, supplies, written material or other valuable items left in function rooms, guest rooms or anywhere on Hotel property other than the Hotel safe. State laws will govern Hotel's liability for items stolen in guestrooms or items kept in Hotel's safe. Accordingly, Client agrees that it will be responsible to provide security of any such aforementioned items and hereby assumes responsibility for loss thereof. Client may not rely on any verbal or written assurances provided by Hotel staff, other than as provided in this Agreement.

<u>INSURANCE</u>: Property of Client is the sole responsibility of the Client and/or its owner. Client agrees that it has procured sufficient insurance to cover the loss of such property. Client hereby waives any claims under Hotel's insurance policy for the loss of Client's property or the property of any of its attendees or invitees.

FORCE MAJEURE: No damages shall be due for a failure of performance occurring due to Acts of God, war, terrorist act, government regulation, riots, disaster, or strikes, any one of which make performance impossible. The Resort shall have no liability for power disruptions of any kind. The performance of this Agreement is subject to any circumstances making it illegal or impossible to provide or use Hotel facilities, including Acts of God, war, government regulations, disaster, strikes, civil disorder or curtailment of transportation facilities. This Agreement may be terminated for any one of the above reasons by written notice from Hotel.

DISPUTE RESOLUTION: Hotel and Client agree to use its best efforts to resolve any disputes under this Agreement through informal means. In the unlikely event that formal action must be taken, this Agreement will be interpreted in accordance with the laws of the State in which the Hotel is situated and the exclusive venue for any dispute arising out of this Agreement shall be in the county or city in which the Hotel is situated. The prevailing party to any litigation shall be entitled to recover, in addition to damages, all legal costs and reasonable attorney fees as fixed by the Court, both at the trial and appellate levels, and in any bankruptcy case and post judgement proceedings.

To the extent allowed by law, the parties hereto hereby waive the right to a jury trial in any action or proceeding regarding this Agreement.

**ENTIRE AGREEMENT:** This Agreement and any Exhibits hereto constitute the entire agreement between the parties and supersede any previous communications, representations or agreements, whether written or oral. Any changes to this Agreement must be made in writing and signed by authorized representative of each party.

MISCELLANEOUS: The persons signing this Agreement for Hotel and Client each warrant that they are authorized to bind the Hotel and Client, respectively. Any provision of this Agreement that is deemed unenforceable shall be ineffective to the extent of such unenforceability without invalidating or rendering the remainder of this Agreement invalid. Each party shall execute such other and further documents as may be necessary to carry out the intention as well as to comply with the provisions of this Agreement.

**NO ASSIGNMENT:** Client may not assign or transfer this Agreement or any part thereof without the written consent of Hotel. Any attempted assignment or transfer by Client without such consent may, at the option of Hotel, be deemed to be a cancellation of this Agreement by Client, in which case Client shall remain liable for all liquidated damage charges set forth herein.

RIGHT OF HOTEL TO TERMINATE: If any information provided by Client to Hotel regarding Client's financial status, its activities, purpose or other material information about Client changes or is incorrect, Hotel shall terminate this Agreement in whole or part and Client will be liable for all payments due pursuant to Section 5 above.

RIGHT OF INSPECTION/ENTRY: Hotel will have the right to enter and inspect all functions. If Hotel observes any illegal activity or activity that may result in harm to persons or objects, Hotel has the right to immediately cancel the event, in which case all of Client's guests and invitees must immediately vacate the event room premises. In such event, Client will remain liable for all fees and charges related to the function pursuant to the terms of this Agreement.



### **ROOM RESERVATION PROCEDURES**

In order to assign specific room types to your attendees, each guest room in your Room Block must be confirmed no later than **10/11/2024** ("Reservation Due Date"). The Hotel has no obligation to provide room nights beyond those contained in the Room Block.

### Online Reservations:

In order to assign individuals to specific rooms, room reservations will be required. Your attendees must make their reservation requests online, through the reservation link provided by the Hotel. Attendees must identify themselves online as part of your group by inserting the group identification code, which will be provided to you by Hotel. You must separately provide the Hotel with any attendee's VIP status. It would be appreciated if the Hotel could be included on the attendee mailing list (traditional mail or e-mail), to stay informed as to when reservations are likely to begin arriving. The Hotel does not confirm reservations to individual attendees in writing. The Hotel reserves the right to change the method used, information required, email address or other aspects of the reservation process.

After Reservation Due Date as described above and prior to your arrival date, all room nights which have not been reserved as described above will be deemed to be room nights which your group will not use, and they will become subject to the attrition provisions herein. Such room nights will at that date be returned to the Hotel's general inventory. Reservation requests from your attendees received after Reservation Due Date will be accepted on a space available basis, at the higher of the contract rate or rate available at that time. Should such requests be accepted, such room nights will be credited to your block for purposes of any calculation of attrition.

Each guest will be required to present a valid credit card upon check-in on which an amount of sufficient pre-authorization can be obtained to cover the room and tax charges for the length of the guest's stay, plus any charges for the guest's use of the Hotel's ancillary services. Should any guest not settle his or her account in full upon departure, you will be responsible for the outstanding balance (which may be added to your Master Account or billed to you separately).

### **GUARANTEED ATTENDANCE AND MENU SELECTIONS**

Though this number will not affect the Agreed Minimum Food and Beverage Revenue figure noted below, the final attendance for your function must be received in writing by the event services office NO LATER THAN 12:00PM, three (3) working days before the date of the function. This will be the number for whom the Hotel will prepare food for the function. The Hotel cannot be responsible for service, accommodations or guaranteeing the same menu items for more than three percent over your guaranteed number of people. If a guarantee is not given to the Hotel by the specified time and date, the original estimated attendance would be considered the final guarantee. Your final menu selections must be made no later than 10 days prior to commencement of your Event. A Banquet Event Order will be sent to you to confirm all final arrangements and prices. If you do not advise Hotel of any corrections or changes to the Banquet Event Order by the date requested by Hotel, the Banquet Event Order will be considered accepted by you as correct. Group will be responsible for the charges listed on the Banquet Event Order or the Agreed Minimum Food and Beverage Revenue figure, whichever is greater, plus applicable tax and service charges.

### SERVICE CHARGE

A service charge of 25% (or the current service charge in effect on the day of the Event) will be assessed on all charges relating to your Event including, but not limited to, food and beverage, audio visual, connectivity, meeting room rental, labor fees and any other charges relating to your Event, plus any applicable state and/or local taxes. This service charge is not a gratuity and is the property of Hotel to cover discretionary and administrative costs of the Event. We will endeavor to notify you in advance of your Event of any increases to the service charge should different amounts be in effect on the day of your Event.

### AGREED MINIMUM ROOM NIGHT REVENUE

Based on the Total Contracted Rooms and the stated rates, the "Agreed Minimum Room Night Revenue" is \$13,200.00.

### AGREED MINIMUM FOOD AND BEVERAGE REVENUE

Based on the above Schedule of Events, the "Agreed Minimum Food and Beverage Revenue" to the Hotel from such events is \$10,000.00. This amount does not include service charges or taxes, if applicable, which are noted separately herein, and any additional requested function space or food and beverage shall be extra.

### ROOM BLOCK AND SERVICES COMMITMENT

When you contract for a block of rooms and meeting facilities and for food and beverage services, those room nights, facilities and services are removed from our inventory and considered sold to you, and the Hotel makes financial plans based upon the revenues it expects to achieve from your full performance of this Agreement. It is impossible for the Hotel to know in advance whether or under what circumstances or at what rates it would be able to resell your contracted room nights, services or facilities if you do not use them, either as the result of a cancellation of your Event ("cancellation") or as the result of usage of less than your Total Contracted Rooms and/or contracted food and beverage services for the above Schedule of Events ("attrition"). In most instances, when groups do not use their contracted room nights or services, the Hotel is unable to resell those room nights or services and even when room nights or services are resold, they are generally not resold at the same rates, may be resold to groups which would have utilized the Hotel at another time, are resold to groups that do

have the same needs as the original group, etc. Even when rooms or services may be resold, it is costly to remarket the rooms and facilities, and such efforts divert the attention of our sales staff from selling the Hotel's rooms and facilities for other times. While your Room Block has been held out of our inventory, we may have turned away more lucrative groups in order to meet our commitment to you.

For all these reasons and others, the Parties agree that in the event of cancellation or attrition, the following charges, which represent a reasonable effort on behalf of the Hotel to establish its loss prospectively, shall be due as liquidated damages. Because the Hotel reasonably expects to derive revenue from your Event above and beyond the revenue derived from the provision of room nights and food and beverage services, and because it is difficult to estimate the actual revenue which may be derived from your Event, the amounts due as and for liquidated damages are intended to compensate the Hotel for all of its losses associated with cancellation and/or attrition, which is addressed separately in the attachment hereto, and which shall be due in addition to the liquidated damage amount set forth herein.

### **ATTRITION**

We agree to allow for a 20% reduction in the "Agreed Room Night Revenue Figure" if said reduction is requested by the Reservation Due Date. After the Reservation Due Date, Group will be responsible for the total value of the guestrooms reserved on that date (# of rooms held x room rate) or the original contracted block with attrition, whichever is greater. Any applicable taxes and service charges will be added and posted as a charge to Group's Master Account.

### CANCELLATION

It is understood that Hotel loses substantial revenue upon the Group's cancellation of an event. The amount of those losses is often difficult or impossible to determine. Hotel has set forth the following fee schedule in the event of cancellation. The parties agree that these fees are a fair and reasonable estimation of Hotel's loss as a result of cancellation. Group shall pay the cancellation fee as liquidated damages, plus applicable taxes, if Group cancels or is deemed to have cancelled the Event.

If any single function is cancelled, the Group is responsible for the meeting room rental and any other applicable charges associated with that function. The Group is still expected to meet the Agreed Minimum Food and Beverage Revenue. Group agrees to notify Hotel in writing within five (5) business days of any decision to cancel. If the entire Event is cancelled Group agrees to pay Hotel, as follows:

### **CANCELLATION FEES:**

Cancellation Fee is based on Agreed Minimum Room Night Revenue and Agreed Minimum Revenue, all other applicable Event charges (e.g., setup charges, audio visual charges, etc.), service charges and applicable taxes for a total amount of \$33,200.00.

Your written notice of cancellation must be delivered to Hotel, and may be made by facsimile or electronic transmission. Cancellation date will be considered the date such notification was received by Hotel. Liquidated damages resulting from cancellation shall be due and payable at the time of cancellation.

### **PAYMENT REQUIREMENTS**

In addition to any other amounts authorized by this Agreement, the following items shall be charged to the Master Account:, cancellation charges, charges for third-party services and/or supplies arranged through the Hotel and agreed in advance by the Group, and any other charges billed to the Master Account at the request of the authorized representative of the Group, as designated by the Group in advance of the Event, plus applicable taxes and governmental charges.

A secure credit card link will be sent, please complete and return it with the signed Agreement. The credit card will be charged in the case of, cancellation charges, or any other authorized charges. All credit card charges over \$10,000.00 will incur a 2.5% processing fee unless prohibited by law.

If any deposit payment is not made when due, Hotel may, at its option, deem the Event to be canceled, in which case cancellation charges will apply as noted above and the Hotel will retain any deposits on hand and apply them to the cancellation charges.

Individual guest accounts are paid via the credit card provided by the guest at check-in.

### TAX EXEMPT STATUS

If Group maintains a tax exempt status, Hotel must be provided with a valid exemption certificate no later than thirty (30) days prior to Group's arrival in order to be exempt from taxes. Please note, tax exempt status pertains to the Master Account only. Individual attendees are not tax exempt. Tax exempt status applies to sales tax only; other taxes may apply.

### **AUDIO-VISUAL EQUIPMENT**

Group agrees to work exclusively with Hotel or Hotel's exclusive audio-visual provider for Group's audio-visual needs. Any exceptions require Hotel approval and shall be subject to a Hotel fee of \$1500.00, plus tax. Applicable service charges and taxes will apply to all charges for audio-visual services, whether provided by the Hotel or Hotel's exclusive provider.

### INSURANCE AND INDEMNIFICATION

Hotel and Group each agree to carry and maintain and provide evidence of liability and other insurance in amounts sufficient to provide coverage against any claims arising out of its activities or relating to its respective obligations under this Agreement, with liability coverage of not less than \$1,000,000.00 per occurrence. 


